

# 2020 Australian Esports University League

## Play Of The Game (POTG)

### Season 2 Competition

Last updated: 18 August 2020

#### 1. Eligibility

Competition (the "Competition") is open only to enrolled University students attending an Australian University who have completed the full signup process (found on <https://uni.ael.org.au>) to the Australian Esports University League.

In order for a submission to be eligible it must meet the following criteria:

- The entrant must be playing in the 2020 AEL Uni League Semester 2;
- Submitted footage must be from an official AEL University League match from Semester 2, 2020.
- Footage must not be edited with any music, overlays or effects.
- Footage must be family friendly (no profanity).

Entrants must be 18+ years of age at the time of entry to be eligible to win the Prize as defined in section 5. The competition is open to the legal residents of Australia and is void where prohibited by law. Employees of Critical Hit Entertainment ("sponsor"), their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Competition. The Competition is subject to all applicable federal, state and local laws and regulations.

In order to be enter the competition you must submit a POTG video clip from an AEL University League match by way of posting in the #potg-season2 channel of the AEL UNIVERSITY discord server and the eligibility criteria as set out in section 1 must be met.

The entry must fulfill all Competition requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Critical Hit Entertainment. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of Critical Hit Entertainment.

The person making the submission is eligible for the prize, the submission may feature person's appearing in the clip other than themself.
